1 INSPECTIONS

1.1 Dates of inspection

The ONR site inspector made inspections on the following dates during the quarter:

- 4-7 July
- 15-18 August
- 19-22 September

ONR will change the nominated site inspector for Dungeness B on 3 October 2016.

The site inspector was accompanied by other inspectors as follows:

- A fuels specialist inspector for a system based inspection on fuel assemblies on 5-6 July and on 16 August.
- A structural integrity specialist inspector for a system based inspection on diverse shutdown systems on 19-20 September.
- The incoming nominated site inspector for a handover visit on 21-22 September.

2 ROUTINE MATTERS

2.1 Inspections

Inspections are undertaken as part of the process for monitoring compliance with:

- the conditions attached by ONR to the nuclear site licence granted under the Nuclear Installations Act 1965 (NIA65) (as amended);
- the Energy Act 2013
- the Health and Safety at Work Act 1974 (HSWA74); and
- regulations made under HSWA74, for example the Ionising Radiations Regulations 1999 (IRR99) and the Management of Health and Safety at Work Regulations 1999 (MHSWR99).

The inspections entail monitoring licensee's actions on the site in relation to incidents, operations, maintenance, projects, modifications, safety case changes and any other matters that may affect safety. The licensee is required to make and implement adequate arrangements under the conditions attached to the licence in order to ensure legal compliance. Inspections seek to judge both the adequacy of these arrangements and their implementation.

In this period, routine inspections of (site/station) covered the following:

- examination, maintenance, inspection and testing;
- management of operations including control and supervision;
- staff training, qualifications and experience;
- modifications to plant, equipment and safety cases;

In general, ONR judged the arrangements made and implemented by the site in response to safety requirements to be adequate in the areas inspected. However, where improvements were considered necessary, the licensee made satisfactory commitments to address the issues, and the site inspector will monitor progress during future visits. Where necessary, ONR will take formal regulatory enforcement action to ensure that appropriate remedial measures are implemented to reasonably practicable timescales.

3 NON-ROUTINE MATTERS

Licensees are required to have arrangements to respond to non-routine matters and events. ONR inspectors judge the adequacy of the licensee's response, including actions taken to implement any necessary improvements.

Matters and events of particular note during the period were:

ONR has recently been informed of an event related to the additional feed system, which is one of the systems that can provide cooling to the reactors in fault situations. During routine testing the licensee found that its diesel pumps could not be demonstrated to operate at extreme high ambient temperatures of up to 36degC. The licensee has used its safety case anomalies process and produced an interim justification for continued operation of the reactors. ONR is monitoring the position and will consider what level of regulatory follow-up is required.

4 REGULATORY ACTIVITY

ONR may issue formal documents to ensure compliance with regulatory requirements. Under nuclear site licence conditions, ONR issues regulatory documents, which either permit an activity or require some form of action to be taken; these are usually collectively termed 'Licence Instruments' (LIs), but can take other forms. In addition, inspectors may issue Enforcement Notices to secure improvements to safety.

No LIs or Enforcement Notices were issued during the period.
