Site Director's Summary (June – September 2017)

Wylfa site operations

The summer months have been a challenging period for defuelling due to a number of pile cap equipment faults and flask filling restrictions caused by persistent problems with the flask handling crane. We have only been able to keep one of the three key defuelling processes in operation for most of the time. However, we have taken the opportunity to carry out a number of engineering improvements and pile cap housekeeping activities to reduce fire and conventional safety hazards during the downtime.




As of 27 September, the reactors are 45% defuelled overall. There are 7,544 spent fuel elements in the dry store cells ready to be flasked, 33,574 spent fuel elements remaining in reactor 1 and 19,769 in reactor 2.

Dry Store Cell 4's (DSC4) nine tonne concrete plug was lifted in July for the first time since the cell was constructed and commissioned in the early 1970's. Since then, the project team have been getting to grips with working in C3 conditions to deploy the recovery tools 7m into the cell and rehearse the delicate, precise manoeuvres needed to cut and remove 37 skip tubes containing intermediate level waste. An ONR and Environment Agency readiness review was conducted in September which resulted in the regulators granting permission for the project to commence retrieval operations w/c 2nd October.


The overcoring tool above a skip tube

The ONR visited site on 19 July to see the revised Asbestos Management Plan in action. From this ONR were able to see that Magnox has met the requirements of the formal Improvement Notice issued in April.

There are three contracting teams supporting the asbestos programme of works: Exova - who carry out asbestos air tests and inspections.

Hertel - who are responsible for asbestos remediation work all over site, except the turbine hall.

Kaefer – whose team of 80 personnel are responsible for the bulk removal and management of asbestos in the turbine hall. This package of work includes removing all the lagging from the pipes that supplied steam to the turbines from both reactor's 39m long pipebridges.



Interserve was appointed as Wylfa's Hard Services Facilities Management supplier on 1 June. They are now responsible for ensuring core maintenance (previously carried out by Civil and Electrical contractors) is completed as per the station plan in addition to providing support services.

Nuclear Safety and Environment Council

The site hosted one of the regular meetings of the Magnox Nuclear Safety and Environment Council and provided a site tour for several external members on the following day. Their comments included:

- Pleased to recognise knowledgeable and enthusiastic staff when walking round the site.
- Areas generally looked well cared for.
- Good engagement with site safety representatives.
- The site tour clearly illustrated the challenges to be dealt with by the Asbestos Management Plan – more external benchmarking was recommended for site staff.
- Appreciated the maintenance challenges being posed by the age and complexity of the fuel route equipment and supported the honest and pragmatic estimates of programme duration which were presented.

The site was pleased to receive the support and advice from external members, and will follow up some more detailed suggestions by further discussion with the asbestos programme.

Maentwrog site operations – Andy McAteer

Maentwrog's annual four week outage commenced on 9 June when both generators were shut down at 9.00am following extended generational periods to lower the lake to its normal pre-outage minimum level. This is to permit its gradual refilling over the following four weeks whilst the outage is in progress. The control gate at the main dam was lowered by simulating an emergency operation, and the draining of the tunnels and the pipelines commenced at 9.30am, this was completed in time for the outage to commence on 12 June.

Dyler & Butler tunnelling contractors carried out planned repairs to both tunnels. Site staff undertook various inspections to the low pressure pipeline

Môn Apprentices, on placement at Wylfa, joined the site team, thereby gaining differing experiences in their skill training.

On the 4 July, re-flooding operations commenced with the tunnels and pipelines recharged within 24 hours. Both generators were returned to service on 6 July.

Rainfall from the 1 April to 27 September was 893.1mm.

Electricity generation is currently ahead of target and availability has been 73 % which is as planned to include the outage period.

Environment, Health, Safety, Security and Quality (EHSS&Q)

The annual Level 1 exercise to demonstrate the adequacy of the site's emergency arrangements to the ONR took place on 4 July. This was described as: 'An excellent demonstration of our arrangements; that was in many areas exemplary, text book stuff.' by our former ONR Site Inspector, Nick Blackburn.

John McGough was appointed as the site's ONR Site Safety Inspector on 1 August.

On the 20 July, an individual suffered a personal injury as a result of a fall from height whilst using a companionway ladder on the pile cap fuelling machine. Fortunately, the individual did not sustain any significant injuries.

On the 23 August, a bag covering a footplate on the flask transporter was found to be above reportable levels on an incoming flask at Valley Railhead.

Monthly Target Zero Safety campaigns have been delivered throughout the reporting period covering the following topics: Environmental Performance, Electrical Safety, Radiological Protection and Fire Safety.

A presentation regarding the site's past, present and future was given to Benllech Over 50's group at the Ex-Servicemen's Hall on 20 July.



Workforce

As of 28 September, there were 304 employees and three Agency Supplied Workers on site (not including Security or Magnox Support Office staff based at Wylfa).

Regional meetings of the Wylfa and Trawsfynydd Site Joint Committees have commenced to discuss potential opportunities to maintain employment for Magnox staff at both sites.

A programme of equality, diversity and inclusion training for all staff will be delivered in the Autumn.

Wylfa in the community

It is great to see that the Welsh Government and the EU awarded Menter Môn's Morlais Tidal Energy Project £4.5m last week. This is really good news for Anglesey's economy and a fantastic opportunity to create sustainable jobs in the marine energy sector.

The NDA has supported the Morlais project with £300,000 seed funding during the last three years to help obtain planning consent and contracts to install the grid connection. The funding enabled Morlais to carry out environmental and biological surveys to gain Natural Resources Wales planning consent. It also supported the project to invite tenders for up to ten tidal energy developers to secure access to a berth in the West Anglesey Demonstration Zone - 14 showed an interest and eight developers were selected to join the project.



The NDA has awarded a 2m package of funding to support Grŵp Llandrillo Menai's plans to build a new four storey engineering skills centre at Coleg Menai's Llangefni Campus and transfer the existing engineering skills centre from the dated Bangor site. The new engineering skills centre will complement the Canolfan Ynni energy skills and construction centres that are already operational. Together, these facilities will create a world-class international training centre for engineering and energy-related sectors.



Wylfa donation

The playpark equipment, located in the grounds of the former Visitor Centre, has been donated to #Caru Amlwch community group who will relocate the equipment to Amlwch in the near future.

Anglesey Montage Writing Festival

66 people attended a programme of English and Welsh literacy workshops, sponsored by Magnox, at Ysgol David Hughes on the 9 September.

Quote for Anglesey Montager:

"The Magnox funding helped us reach writers of all levels, including absolute beginners, within our community and to give them unique opportunities to attend quality tutored workshops and develop their skills and motivation! Some have now sought out local writing groups to join and so continue their work. Thus, this also benefits the existing writing groups across the area by attracting new members. This has enriched our community."



Magnox on the Maes

The National Eisteddfod of Wales, Bodedern was supported with £30,000 Magnox socio-economic funding from the NDA. Magnox exhibited a stand in the Science and Technology Pavilion, as part of the sponsorship package, which was staffed by over 40 volunteers from Wylfa, Trawsfynydd and Cavendish Nuclear throughout the week.

The stand displayed the Wylfa Story from the 1960s to the 2010s and engaged people of all ages with an interactive game that simulated waste segregation on Magnox sites. We are grateful to Môn Communities First for providing the materials and constructing the game board at the training academy's joinery workshop in Holyhead.

The interactive game was also in use at the NDA's National Stakeholder Workshop in September and is booked for the NDA's Supply Chain Event in November.

Gweithredu ar safle Wylfa

Bu misoedd yr haf yn gyfnod heriol ar gyfer gwagio tanwydd oherwydd nifer y methiannau cyfarpar capiau peil a chyfyngiadau ar lenwi fflasgiau a achoswyd gan broblemau parhaus gyda'r craen trin fflasgiau. Am y rhan fwyaf o'r amser, ni fu modd inni gadw ond un o'r tair proses allweddol gwagio tanwydd yn weithredol. Fodd bynnag, rydym wedi cymryd y cyfle i wneud nifer o welliannau peirianneg a gwaith ymarferol ar y capiau peil i leihau peryglon Tân a diogelwch cyffredinol yn ystod y cyfnod segur.




O 27 Medi, mae 45% o'r tanwydd wedi'i wagio o'r adweithyddion. Mae 7,544 o elfennau tanwydd sydd wedi cael ei ddefnyddio yn y celloedd storfa sych, yn barod i'w rhoi mewn fflasgiau, gyda 33,574 o elfennau tanwydd wedi'i ddefnyddio yn parhau yn adweithydd 1 a 19,769 yn adweithydd 2.

Codwyd plwg conrid naw tunnell Cell Storfa Sych 4 (DCS4) ym mis Gorffennaf am y tro cyntaf ers i'r gell gael ei hadeiladu a'i chomisiynu ar ddechrau'r 1970au. 
Yr arf craidd uwchben tiwb sgip

Ymwelodd yr ONR â'r safle ar 19 Gorffennaf i weld y cynllun Rheoli Asbestos diwygiedig ar waith. O hyn, bu modd i'r ONR weld bod Magnox wedi cwrdd â gofynion y Rhybudd Gwella ffurfiol a gyhoeddwyd ym mis Ebrill.

Mae tri thîm contractio'n cefnogi'r rhaglen waith asbestos:
Exova - sy'n gwneud profion aer ac archwiliadau asbestos.

Hertel - sy'n gyfrifol am waith adfer asbestos ar hyd a lled y safle, ac eithrio neuadd y tyrbinau.

Kaefer - y mae eu tîm o 80 o bersonél yn gyfrifol am dynnu swmp yr asbestos a'i reoli yn neuadd y tyrbinau. Mae'r pecyn gwaith hwn yn cynnwys tynnu'r holl ddeunydd lagio o'r pibellau a gyflenwodd y stêm i'r tyrbinau o bontydd peipiau 39m o hyd y ddau adweithydd.



Penodwyd Interserve fel cyflenwyr Rheolaeth Cyfleusterau Gwasanaethau Caled Wylfa ar 1 Mehefin. Maent bellach yn gyfrifol am sicrhau y caiff gwaith cynnal y craidd (a wnaed yn flaenorol gan gontactwyr Sifil a Thrydanol) ei gwblhau yn unol â chynllun yr or saf yn ogystal â darparu gwasanaethau cefnogi.

Mae'n wych gweld bod Llywodraeth Cymru a'r UE wedi dyfarnu £4.5m i Brosiect Ynni'r Llanw Morlais Menter Môn yr wythnos diwethaf. Mae hyn yn newyddion da iawn i economi Môn ac yn gyfle gwych i greu swyddi cynaliadwy yn y sector ynni morol.

Mae'r NDA wedi cefnogi prosiect Morlais gyda chyllid o £300,000 yn ystod y tair blynedd diwethaf i helpu i gael caniatâd cynllunio a chontractau i osod cysylltiad â'r grid.
